**NOTIFICATION / PRESS RELEASE**

**ON-LINE APPLICATIONS ARE INVITED FOR EXTENSION OF PROVISIONAL AFFILIATION INCLUDING SANCTION OF ADDITIONAL SECTIONS FOR THE ACADEMIC YEAR 2019-20.**

Applications are invited through online from the managements of existing Junior Colleges (including composite colleges) in the Telangana State for extension of Provisional Affiliation for the academic year 2019-20 including sanction of Additional Sections in addition to the permanent/original sections indicated in the Letter of Intent or Provisional Permission & Provisional Affiliation Order subject to a maximum of 7+2 sections in terms of G.O.Ms.No.12, dated 09-03-2002.

The managements are informed that the rates of affiliation fee, inspection fee & application fee (Form-II) are shown in online application form. Proposals for sanction of addl. Sections without providing addl. accommodation as required will be summarily rejected. While submitting proposals for provisional affiliation and sanction of addl. Sections if any, the managements are requested to see that the FDR, Registered Lease Deed of the building & playground, Fire safety certificate, sanitary certificate and structural soundness certificate are in force for the period for which they have requested for extension of provisional affiliation etc. The fire safety certificate should be renewed periodically as per the norms of fire services department, otherwise, the proposals will not be considered.

All the college Managements are informed that, the TSBIE will announce the list of affiliated Private Junior Colleges for the academic year 2019-20 to the Public (students and parents community) well in advance before the beginning of the academic year 2019-20 i.e., before the announcement of the admission schedule, as such the parents & students gets ample time to enquire and confirm whether the college has affiliation for the academic year 2019-20 and which courses were sanctioned for the college.

Further it is to inform that, without prior permission of the Secretary, TSBIE, the college Managements should not open new sections. Any such deviation will be viewed seriously, and will make them liable for disaffiliation besides imposition of penalty under Telangana Education Act and the rules made there under from time to time.

The college Managements are hereby requested to apply online in Form-II for extension of Provisional Affiliation including sanction of Additional Sections, from the official website (<http://www.acad.tsbie.telangana.gov.in> (or) <http://www.bie.telangana.gov.in>) of Telangana State Board of Intermediate Education with effect from **10.01.2019**. The application fee, Affiliation fee and prescribed inspection fee should be paid together through on-line payment only. **Offline (Manual) payments through DDs, Challanas and submission of offline Form-II will be summarily rejected.**

Further the Requests for shifting of college premises, change of society, name change of the college etc., should be made along with the affiliation proposals only. After 20.03.2019, the requests for the above will not be considered under any circumstances. Hence the managements of private un-aided junior colleges are requested to adhere to the above instructions scrupulously.

The last date for uploading applications along with necessary enclosures is 31.01.2019 without late fee. Further the time schedule is as follows.


